DESIGN THE CHANGE YOU WANT TO SEE IN THE WORLD.

**Project for awarding grants for young Ukrainian refugees hosted by
Italian architecture firms**

NOTICE OF EXPRESSION OF INTEREST

1. INTRODUCTION

The Russian invasion of Ukraine has sparked one of the worst humanitarian crises in decades. Approximately 5.3 million people – more than 10% of the country's total population – have had to flee to other countries. More than 125,000 people have reached Italy, with a clear prevalence of women, due to the ban on men between the ages of 18 and 60 leaving the country.

Some of these refugees are architects, designers and students of architecture who have had to leave not only their cities and their loved ones but also their professional studies and the work they were doing.

Their skills are the foundations that can enable them to regain that autonomy to which every human being is entitled in order to feel part of this world, to take their place in it and contribute to it.

These young students, planners and designers have seen their cities destroyed and their only desire is to be able to return to their country as soon as possible and start rebuilding it, hopefully better than before.

The contribution of the community of Italian architects, planners, landscapers and conservationists can be crucial in helping them achieve this desire, through the extremely powerful weapons of creativity, design and cooperation.

“Design for Peace”, therefore, is a project that aims to start a path to define a vision of post-war reconstruction of Ukrainian cities.

The project, proposed and managed by the National Council of Architects, Planners, Landscapers and Conservationists, a public non-economic body at the Ministry of Justice, and the Association of Architects, Planners, Landscapers and Conservationists of Rome and its Province and implemented in cooperation with the Ministry of Development of the Communities and Territories of Ukraine through the Embassy of Ukraine in the Italian Republic, involves awarding 10 grants to ten young Ukrainian students and architects, who are to be selected through this Announcement.



2. SUBJECT OF THE PROCEDURE

This procedure for expressing interest calls for awarding 10 grants to ten young Ukrainian students and architects under the age of 35 who have found refuge in Italy following the events of the war and who have already identified ten Italian professional firms with which they have made a hospitality agreement.

Workshops will be set up on recovery and re-design projects of some of the iconic locations of the Ukrainian cities hit by the violence of the ongoing war. The planned locations will be directly designated by the Ministry for the Development of the Communities and Territories of Ukraine through the Embassy of Ukraine in the Italian Republic.

3. BENEFICIARIES

The expression of interest is directed at Ukrainian architects and students of architecture, aged 35 years or under, currently on Italian soil with refugee status or under temporary protection after 24 February 2022.

These Ukrainian architects and students of architecture must have already identified just as many Italian professional firms willing to offer hospitality, technical support and know-how for workshops and the definition of the projects. These firms will have to identify and provide an architect tutor with a degree aged under 35.

4. REQUIREMENTS

- In order to be able to participate in this Notice, the interested parties must meet the following mandatory requirements:
 - Ukrainian nationality;
 - currently present on Italian soil with recognized refugee status or under temporary protection in connection with the outbreak of the war in progress (February 2022);
 - date of birth after 28 October 1987;
 - knowledge of the English language;
 - degree in architecture or equivalent, or enrolment in a course of university-level studies in architecture or equivalent;
 - agreement with a hosting Italian firm meeting the following requirements.
- The hosting Italian firms must meet the following mandatory requirements:
 - registration in one of the Italian Associations of Architects, Planners, Landscapers and Conservationists;
 - presence of a professional whose date of birth is after 28 October 1987;
 - knowledge of the English language.

5. NUMBER AND AMOUNT OF GRANTS

There are 10 grants worth €1,500.00 per month, for the four months of the workshops, to be awarded to 10 Ukrainian architects.

There is to be no financial reimbursement for the hosting professional firms.



6. TERMS AND PROCEDURES FOR PRESENTING EXPRESSIONS OF INTEREST

Expressions of interest may be sent from 10 a.m. on 24 October 2022 until 4 p.m. on 28 October 2022 to the e-mail address direzione.cnappc@archiworldpec.it

The subject of the e-mail must be: “*DESIGN FOR PEACE project – Candidacy*”.

The application must state:

- personal data;
- place of provenance and current place of residence in Italy;
- data of the hosting Italian firm.

It must also be accompanied by:

- photocopy of identity document;
- educational and vocational curriculum;
- hospitality agreement with the hosting Italian firm.

7. RANKING FORMATION

A Technical Commission specifically appointed by CNAPPC will be appointed to verify the applications received.

The ranking will be formed based solely on the chronological order in which the applications arrive, after verifying that the requirements of point 4 above have been met.

The grants will therefore be awarded to the first 10 applications received in chronological order, which have been found to comply with the required mandatory requirements.

8. EXHIBITION AND PUBLICATION OF THE WORKSHOP RESULTS

At the end of the workshop period, presumably by April 2023, the projects will be collected, published in a specific catalogue and presented in a dedicated exhibition to be held in Rome, at the Roman Aquarium, headquarters of the Association of Architects, Planners, Landscapers and Conservationists of Rome and its Province.

9. OTHER INFORMATION

For the duration of the workshop, the beneficiaries of the grants shall not in any way be included in the staff of the hosting professional firm, and the relationship of cooperation shall not in any way be an employment contract. This activity, therefore, does not entitle the hosting professional firm or the venture's organizing bodies to any subsequent claim or obligation.

The ownership of the projects will remain with their authors who can donate them to the Ministry for the Development of the Communities and Territories of Ukraine.

However, the selfsame subjects may use the work for other purposes and make it known to other bodies or persons or disclose it in publications, only with prior notice to the CNAPPC and to the Association of Architects, Planners, Landscapers and Conservationists of Rome, and in any case always stating that this work has been carried out on behalf of and within the framework of the DESIGN FOR PEACE PROJECT, under the auspices of CNAPPC and OAR.

Privacy policy statement

(rendered pursuant to Article 13 of the European Regulation No. 679/2016)

1. Introduction

The National Council of Architects, Planners, Landscapers and Conservationists (hereinafter CNAPPC) is required to provide certain information on the use of the data subject's personal data, in accordance with the provisions of art.13 of the European Regulation No. 679/2016 (hereinafter also the “GDPR”).

2. Data Controller

The controller of the personal data referred to in this policy is CNAPPC, based in Rome, via Santa Maria dell’Anima n. 10, postcode 00186, pec/certified email address: direzione.cnappc@archiworldpec.it.

3. Data Protection Officer

CNAPPC has designated the Data Protection Officer (DPO), who can be contacted by e-mail: dpo@cnappc.it, also for the purpose of exercising the following rights.

4. Subjects authorized for processing

Personal data are processed, both electronically and on paper, by the subjects designated by CNAPPC within their staff, who have been given appropriate instructions on measures, precautions and modus operandi for the concrete protection of personal data.

5. Purposes of processing

The processing of the personal data provided by you is intended solely for performing institutional functions and, therefore, in accordance with art. 6 subsection 1, lett. e) of the GDPR, does not need your consent. In particular, your data will be used in the process of awarding grants under the *design for peace* project.

No activities involving decisions based solely on automated data processing, including profiling, will be carried out.

6. Categories of personal data processed

For the purposes set out above, personal data such as first and last name, nationality, date and place of birth, residence or domicile, qualifications, professional experience, refugee status and e-mail address will be processed.

If the selection is successfully passed, further data such as bank details may be requested and processed for the purpose of paying out the grants.

7. Personal data recipients

Only for the purposes set out in subsection 5 (Purposes of processing and constructive notice), the data may be communicated to other public subjects (e.g. Association of Architects, Planners, Landscapers and Conservationists of Rome and its Province, Embassy of Ukraine in Italy and other subjects taking part in the venture) or private citizens (e.g. hosting Firms).

Some of these subjects, including providers of IT services that the data controller uses, may, if the conditions are met,



receive and process personal data as data processors in accordance with art. 28 of the GDPR.

A complete list of data processors may be requested from the data controller in accordance with subsection 10 below (Rights of data subjects).

Certain personal data, with the exception of specific data pursuant to Art. 9 of the GDPR may be distributed as part of the activities of publicizing the project as stated in subsection 8 of the Announcement.

8. Transfer of personal data to non-EU countries

Personal data are not transferred outside the European Economic Area.

9. Retention period

The personal data are to be retained for a period no longer than that necessary for pursuing the above-mentioned goals and, in any event, for no longer than one year after the end of the workshop period.

To this end, also by means of periodic checks, the close relevance, non-redundancy and essentiality of the data in relation to the current relationship, service or task to be established or terminated, also in relation to the data which you supply on your own initiative, shall be constantly checked. Data which, also as a result of the checks, are found to be in excess or irrelevant or non-essential shall not be used and, where possible, shall be deleted, destroyed or blacked out.

The legal requirements for the retention of documents relating to the procedure remain.

10. Rights of data subjects

Unless there are grounds for exclusion depending on the purposes or methods of processing personal data, all Data Subjects are given the opportunity at any time to exercise a number of rights, including:

- a. accessing the personal data held by the Data Controller, obtaining proof of the purposes for which they are processed, of the categories of data involved, of the recipients to whom they may be communicated, of the applicable retention period and of the existence of automated decision-making processes;
- b. obtaining the rectification of inaccurate personal data concerning them without delay;
- c. obtaining the deletion of their personal data, where permitted;
- d. obtaining a restriction on processing, where permitted;
- e. objecting, in whole or in part, to the processing of their personal data in the cases provided for;
- f. lodging a complaint with the Italian Data Protection Authority pursuant to art. 77 of the GDPR.

Requests to exercise rights in favour of the data subject may be informally addressed to CNAPPC using one of the e-mail addresses indicated in points 2 and 3 above.

11. Provision of data

The provision of data is optional, but necessary for the purposes indicated above. Failure to provide data will result in it being impossible to award a grant.
